Context of VPSJ's MESL Work

- Origins 1999 study One Long Struggle
- Two recurring themes
- Poverty experiences as material and social deprivation.
 General Lack of Awareness of importance of social inclusion
- Ad hoc approach to Social Welfare Payments and NMW rates decision made – statistical and political basis No apparent awareness of the need to evaluate buying power No apparent awareness of the need for evidence based policy

The VPSJ saw the need to explore new approaches to understanding and communicating the impact of an inadequate income on the daily life of people, many of whom live in poverty

Minimum Essential Standard of Living

From 2006 the VPSJ has used the Consensual Budget Standards Methodology to determine goods and services which households and individuals require at a minimum level to meet Physical, Psychological, Social needs = MESL

French Study 2014 -2015 "What is essential for taking part effectively in social life"

Two Key Principles

- An Adequate Standard fulfilment of material and social needs – to ensure social inclusion
- 2. The Experts of what it meant and what is needed – members of the general public drawn from different socio-economic backgrounds who deliberatively and collectively reach a consensus

An MESL is closely influenced by contemporary needs, norms and customs which cannot be adequately determined by theoretical experts

Or by consumer expenditure patterns based on behaviour of 70% or 80% population The VPSJ is aware that an income of 60% of median disposable income, on the whole falls short of what is required for an MESL The VPSJ approach (*Consensual Budget Standards Method*) is based on deliberation, listening and the interaction between people and experts

We seek to complement conventional methods of measuring poverty and what is needed to reduce it VPSJ seeks to promote an MESL for the general population

- A standard below which no one should be expected to live (the data is updated annually)
 - In this context, we respond to Budget 2016

Research in 2015 showed

- Inflation CPI overall rate showed a decline
 0.6% while the rate in relation to the MESL
 was higher in 2015 than in 2008 by (0.3%)
- 191 of 214 households in the urban sample could not meet the cost of an MESL
- High cost of private childcare and private rented accommodation substantial impact on cost of an MESL

The VPSJ recommended

Increase in Child Benefit €5

Qualified Child 13-18 years from €29.80 – €35.00

- OPF increase from €188.00 €193.00
- Rent Supplement ceiling limit
- Living Alone Allowance to €11.40
- Fuel Allowance to €25 for 26 weeks

Impact Budget 2016

- Welcomed increase in
 - Child Benefit
 - Christmas Bonus to 75%, December 2016
 - State Pension and Fuel Allowance
 NMW to €9.15 per hour
- 7 of the Social Welfare households dependent composition which could in 2015 afford a MESL can no longer do so in 2016

2015: 191 out of 214 urban cases inadequate

2016: 198 out of 214 urban cases inadequate




Social Welfare Trends

- Reduction in social welfare supports, including:
 - Jobseeker Personal & Qualified Adult rates
 - Child Benefit
 - Back To School
 Allowance
 - Fuel Allowance
 - Household Benefits
 Package

- Reduction in rates is compounded as cost of MESL has risen
- Not keeping pace with costs is in effect a cut
- Combined reductions amount to a 5% decrease in support for social welfare dependent households with children


Budget 2016 Social Welfare Increases

FULL-TIME, NMW PRIVATE RENTED HOUSING






